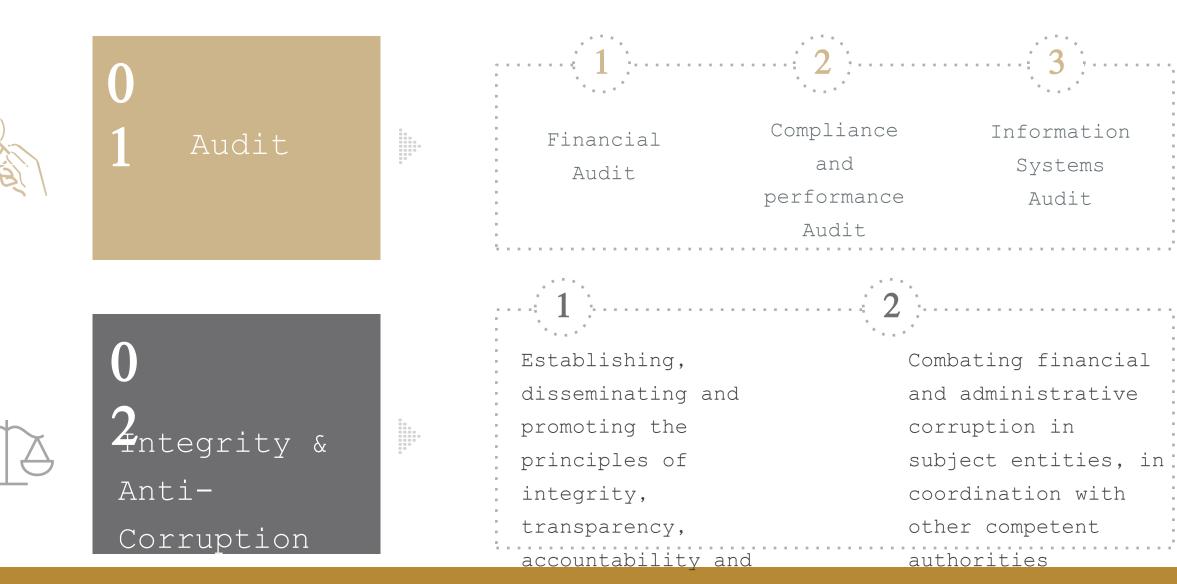

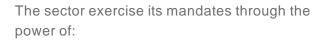
Integrity and Anti-corruption Sector

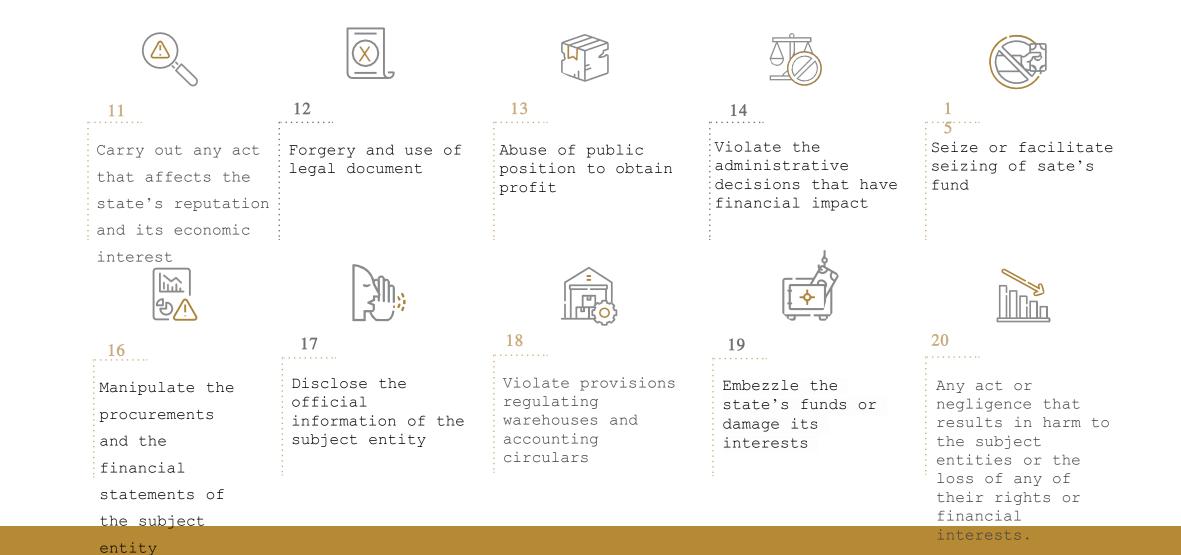

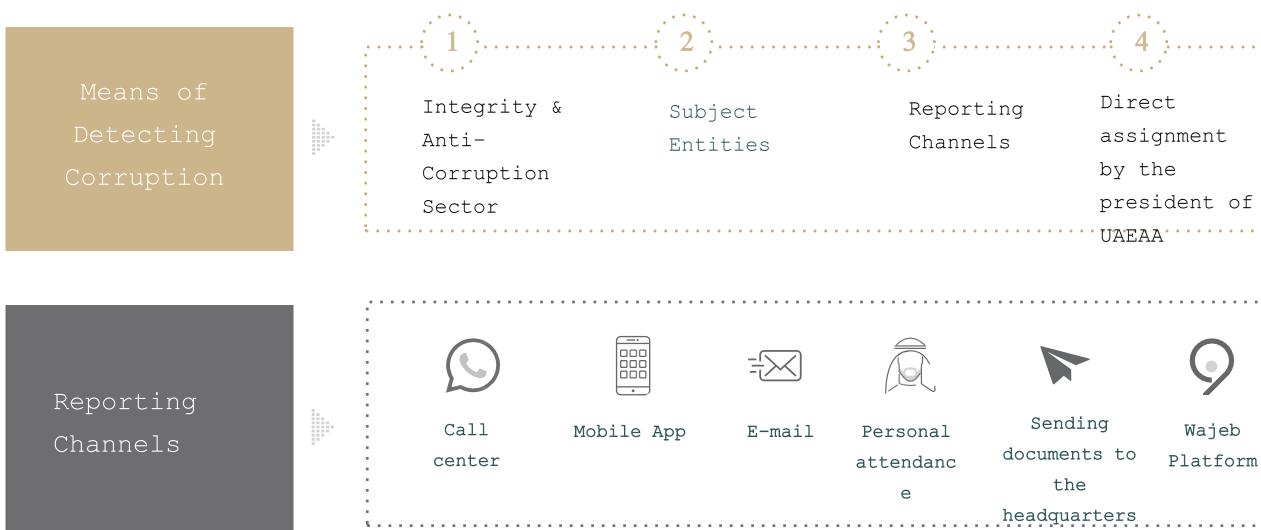

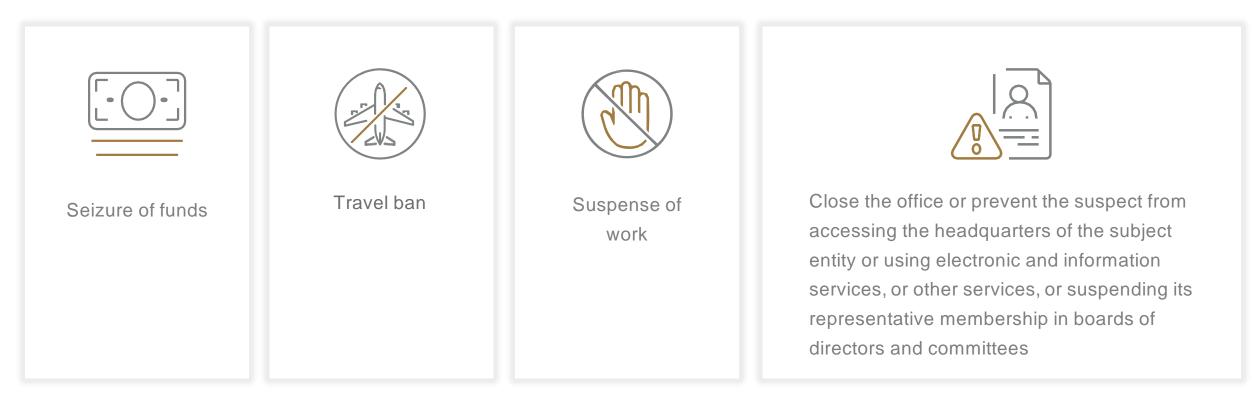

Provide protection at residence, keep their identity confidential, and ensure that they are not subject to any discrimination in their workplace as well as not being punished for reporting administrative and financial violations Rewarding the Whistleblowers and

Witnesse

A moral or material reward may be granted to any person who provided a significant information led to the disclosure of any administrative and financial violation in accordance with the controls set by the UAEAA in the Anti-Corruption Procedures Regulation Mitigation of or exemption from sentence

Based on UAEAA's recommendation, the President of the UAE may exempt the penalty if the suspect admitted committing a violation before it was disclosed, or if reporting made after disclosure and led to arrest the other violators or recovery of the public funds. Settlement and Recovery of Public Funds

The President of the UAEAA, after the approval of the President of the UAE, may close the administrative investigation upon reaching a settlement with the violator in which led to recover the public funds, cooperating with the governmental bodies and disclosing important

WAJIB Platform for Individuals

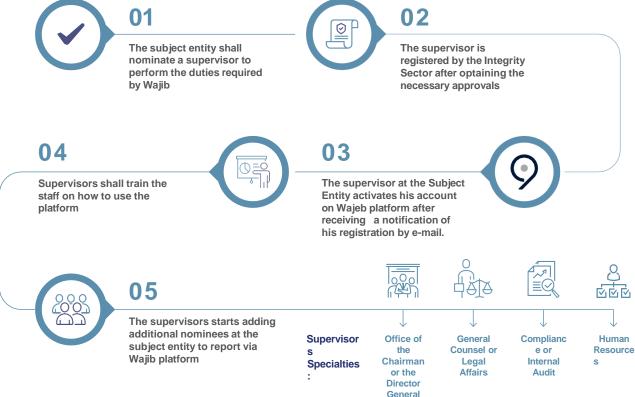
- Wajib platform is a safe and secure channel that allows individuals to confidentially report incidents of administrative and financial misconduct.
- Through the platform individuals can confidentially register and report any case of misconduct and the concerned team will assess the case and will call them back to gather more details (if applicable).
- individuals will be asked to register their personal details and verify their identity by inputting a one-time password (OTP) which will be sent to the mobile number.
- Once the identity is confirmed, individuals must answer questions to identify what has happened and record these details.

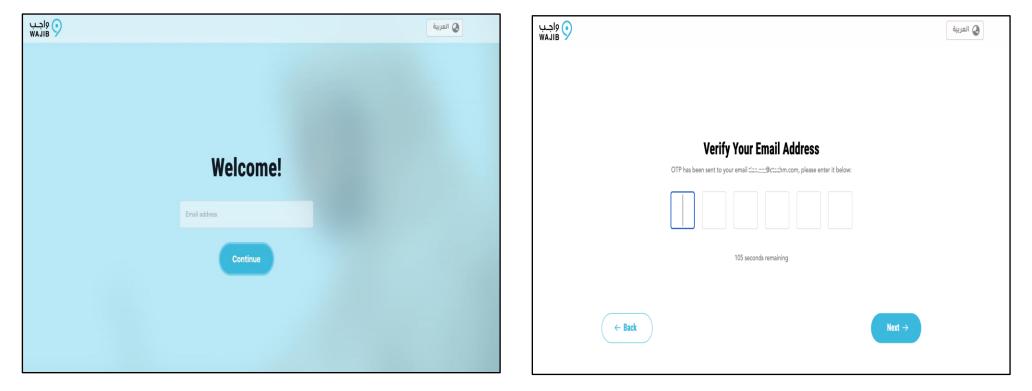
Notes

- The supervisor shall follow up the procedures of all communications received from within the entity or attributed to it through Wajib platform by the Integrity and Anti-Corruption Sector.
- Upon termination of the services of any of the assigned supervisors, they must be replaced by another employee or to cancel his account and inform the ADAA of such.
- Each supervisor must inform ADAA of the incident subject of the violation within 5 working days from the date of his knowledge of it.
