

Allow us to present to you the activities carried out by the WG Secretariat during the past period since the 14th WGFACML Meeting that was hosted virtually by the ASA on November 24th, 2020. Pertaining to <u>Developing and</u> Finalizing Guidelines, the WG Secretariat has coordinated with the INTOSAI KSC Chair; SAI India, to publish the Guideline "Audit of Corruption Prevention in Public Procurement" led by SAI Austria on the INTOSAI Community Portal for an Exposure Period of 45 days ending on May 29th ,2022. Any further comments from the INTOSAI Community would help to finalize the Guideline's legal assessment and thus to issue its Quality Assurance Certificate.

According to Goal 2 - Objectives 1 and 2

Pertaining to Promoting Building Capacities of SAIs' **Professionals in the Field of Fighting Corruption** and Money Laundering as well as Activating the International Cooperation between the WGFACML and the International Agencies, the WG Sectt. is in the process of negotiating the organization of a training program for the WG member SAIs in order to satisfy your training needs related to subjects concerning fighting corruption and money laundering in co-operation with national as well as international entities.


SAIs' publications in the field of fighting corruption and money laundering.

<u>Virtual Meetings</u>

H.E. Counsellor/ Hesham Badawy; the ASA President and the INTOSAI WGFACML Chair, and a delegation from the ASA including the WG Secretariat have virtually participated in the 75th INTOSAI Governing Board Meeting that was held on November 23rd, 2021 and which resulted in many resolutions, the most prominent of which are:

The adoption of the proposal to present SAI Egypt to the INCOSAI XXIV as the candidate of the AFROSAI Region for hosting the INCOSAI XXV in the year 2025. This item will be endorsed during the INCOSAI XXIV that will be held in November 2022 in Brazil.

- > The approval of the Rules of Procedures for INCOSAI XXIV.
- The approval of the production of a concise INTOSAI Strategic Plan (2023-2028), retaining the existing four-goal structure and renaming the "Crosscutting Priorities" to be the "Organizational Priorities".



> The Sectt. participated in various virtual meetings with members of the World Bank and some national entities in order to negotiate organizing a training program for the WG member SAIs according to their training needs.

The WG Sectt. has participated in a number of virtual meetings as follows:

> The 13th KSC-SC Meeting that was hosted virtually by SAI India; the KSC Chair, where the WGFACML Dashboard for the previous period was presented and approved. The Meeting endorsed the hosting of SAI Egypt of the 14th KSC-SC Meeting in September 2022 in case it will be held physically.



In its perpetual endeavour for innovation and for having a unique specific character for our Working Group, the WG Secretariat - together with the WG member SAIs have agreed on a very distinct and professionally designed Logo for the WGFACML. The Sectt. wishes to thank the SAIs that provided us with their feedback which helped in reaching our unique identity.
