Introduction

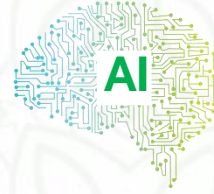
- **Mandate:** Empowered by the Constitution and Public Audit Act, we are Tanzania's guardian of public spending.

Outcomes:

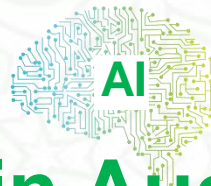

- **Scope & Wide Coverage**

- **Statutory Deadline**

Fixed deadlines may impact audit thoroughness.



- **Language Barrier**

- i. Bilingual report requirements in English and Kiswahili.
- ii. Potential for misinterpretations due to English not being the primary language.

- **Big Data:**

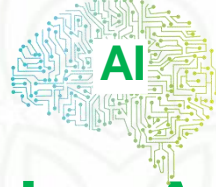
Modern auditing techniques required to manage and analyze vast data sets.

Staying Current

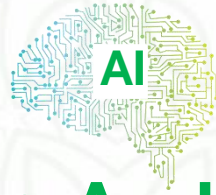
